9. **Snow Warden:** Salt has been distributed around the parish but stocks are now very low. Cllr Waters will order more. There has been a report of a damaged and moved grit bin at Menda Hill – Cllr Waters and Gilbert will take a look. A grit bin is needed at Salt Box Cross – Cllr Waters will contact Cllr Ball to find out how to get one.
10. **Playground:** The Climbing Frame is still cordoned off. Two parishioners have offered to repair the climbing frame so it can be used, for an anticipated cost of up to £300. The Clerk will apply for a funding grant to cover the cost. Cllr Rockett also pointed out that the ground around the frame was unsafe due to protruding concrete. She will contact ROSPA and find out about rubber matting specifications. Barking chippings were also discussed if the rubber matting does not work - **Agreed**
11. **Flooding:** Cllr Levy - Sand and sacks are available but need to be stored somewhere. Cllr Rockett will ask the PHMC if we could keep sand at the back of the hall or in a corner of the carpark.
